4. SLC Charter Changes

That the proposed changes in the SLC Charter be approved.

Discussion: Hilary Williamson presented a comprehensive overview of the proposed Charter changes. The main one proposed moving from a Co-chair model (French and English) to a Chair, Vice-chair model. These changes were recommended after years of consideration, a survey, extensive consultation in Sections, and unanimous SLC Board approval. Hilary explained that, if approved, the change would not take effect until after the next SLC General Meeting. A second change was recommended by LPC Legal to address the situation when Section GMs fail to nominate Officers.

There followed a vigorous discussion on the proposed changes, after which the following amendment to the Motion was presented.

Committee for further study.

The Motion to Amend is defeated
